1 Year Limited Warranty

Timberland Cabinetry warrants the original consumer purchaser that cabinet products will be free from defects for a period of one (1) year from the date of purchase. This warranty only applies to normal residential use and is non-transferrable to subsequent owners.

Should defects in material or workmanship exist during the warranty period, Timberland Cabinetry will elect at its discretion to either repair or replace the defective material or component. This warranty only covers parts and materials of the product supplied by Timberland Cabinetry. Items not covered by this warranty include but are not limited to counter tops, appliances, plumbing fixtures, etc. or the costs, including labor to remove and reinstall materials, components, and related parts such as fittings, appliances, etc.

This warranty will become void if the cabinets are in any way modified, faux finished, improperly installed, or damaged prior to or during installation. This warranty will not apply to cabinetry that has been damaged by misuse, neglect, abuse, acts of God, exposure to extreme temperatures or the effects of normal wear and tear. The warranty will be void if cleaned with a nonapproved cleaner (please see the Use and Care Guide for suggested cleaning methods and products). This warranty will become void if the humidity levels in your home are below 45% or above 55% which can result in the shrinking or expansion of fine wood products over time. Timberland Cabinetry highly suggests that a humidity control system be installed in the central HVAC unit to maintain the proper moisture content of 45-55% within the home. This simple addition to your homes environment can greatly improve the air quality in your home for you and your family's health as well as increase the lifespan of all wood products throughout your home.

Natural woods may vary in color, characteristics and may change as they age. For example, white painted solid wood cabinets may eventually show visible cracking around the joints where the wood is joined together. Cabinet colors may slightly darken over time. Sunlight, smoke, household cleaners, and other environmental conditions may also affect the color over time. These are all normal conditions and these variations over time are considered to be the nature of the material. These conditions are not considered defects and do not reduce the integrity of the product and therefore are not covered under this warranty.

The repairs or replacements are contingent upon the current product offering of styles and construction at the time of the warranty claim. If a warranty claim is filed after a product becomes obsolete, Timberland Cabinetry reserves the right to honor the warranty in one of the following manners.

1. To replace the affected component with a new component of the same style.
2. To replace the component and any other components in the residential application to achieve a uniform appearance with a similar and comparable style to the originally purchased style.

If components are replaced, Timberland cannot guarantee that the finish of the replacements will perfectly match the finish and appearance of the components in the residential application. This is due to the natural aging process of wood and finishes.

Timberland Cabinetry reserves the right to alter design, specifications, and materials without obligation to make similar changes to previously manufactured products.

THIS WARRANTY IS THE EXCLUSIVE WARRANTY OF TIMBERLAND CABINETRY AND IS IN LIEU OF AND TIMBERLAND CABINETRY DISCLAIMS ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MECHANICALITY AND FITNESS FOR A PARTICULAR PURPOSE.

This warranty gives you specific legal rights and you may have other rights which vary from state to state. Some states do not allow the exclusion or limitation of incidental or consequential damage, so the above limitation may not apply to you.

To retain replacements or repair under this limited warranty, first contact your authorized Timberland Cabinetry dealer or distributor who will arrange for inspection of the claim. You must furnish proof of purchase to obtain benefits under this warranty. If your home is new construction you may furnish closing documents that show the date you took possession of the residential property. Any claims must be made in writing and must be accompanied by photographs showing the problem.

Customer/Dealer agrees to the above terms and agrees to distribute this warranty agreement to the builders, homeowners, and anyone who may receive delivery of Timberland Cabinetry. By signing below, the recipient, has read all of the terms of the warranty of the cabinetry and agrees to be bound by the above terms. Should any legal issues arise, the customer agrees that this warranty agreement is governed by the laws of the state of Tennessee, County of Maury. The Customer/Dealer agrees and understands the above terms.
